4.1 Team sportscotland Officer – Gavin Macleod

The response had been very poor and, even after telephoning a number of athletes there was nothing new to report.

Looking at the cost effectiveness of leaving the local, Scottish, buses there for the week. Parents have to apply for tickets to attend the opening ceremony. There are 749 Scots going to the games (23% of total). The Alliance Group are providing polo shirts for all the team.

World CP Games – Over 1000 athletes from 40 countries will be attending. We have 33 people covering 4 sports. This is the first time the soccer team has gone away. Swimming team is a young team. Athletics group is an older group. Two CP Bowlers were at the World Championships. Currently there are no CP Table Tennis players. The groups will be away from 20 to 29. Unfortunately these Games cross over with the Cardiff Games.
